Speaker, Panelist and Moderator Guidelines and Suggestions: PEARLS

We are thrilled you are joining us for our upcoming Outpatient Joint Summit! Here are some concepts to consider:

Moderator:

As a moderator, we ask for your ideas and will help you prepare questions that will drive the gist of your discussion to the panelists at least 14 days before the event.

- We will set up a call with your panelists before the conference to help assure everyone is on the same page.
- Create and submit 7-10 questions for your panel.
- At the session we ask you to allow each panelist to introduce themselves and provide 1–2 key thoughts on the subject before the Q&A begins.
- In the Q&A it's important that all speakers get plenty of chances to talk and each speaker talks no more than 30–90 seconds at a time. We want to avoid any one person giving a speech during the Q&A.
- Generally it's always helpful to engage the audience for questions as well and we encourage speakers to interact with each other.

Panelists:

Here, we want you to be very interactive with the panel and the audience. We ask that you prepare a handout with key takeaways and generally don't expect you to prepare a PowerPoint presentation.

- At a minimum, be prepared to verbalize 2–3 things you'd like the audience to have re: PEARLS that they can share with their staff when they return to their ASC. We encourage you to engage with other panelists, drive home two to three takeaways for the audience and to enjoy yourself. The moderator should provide you with the questions before the event.
- Panelists involved with the Collaborative Care Session will need to review and edit their facility-specific data, provided by SLSG, and be prepared to provide a brief overview. Slides will be sent for review by April 1st and must be returned by April 15th.
- Time is our most precious commodity and our goal is to have all attendees return to their ASCs with a strand of PEARLS in the form of knowledge and tools they can use in their various roles.
- We ask that when you introduce yourself (1–2 minute introductions), you provide a couple of key thoughts on the PEARLS.

Speakers:

We are really thankful for you agreeing to spend your time speaking and preparing a presentation. To that end, here are a few things to consider:

- Prepare and don't shoot from the hip. Please be thoughtful and prepare in advance. You are considered subject matter experts in your fields and are speaking in your key areas, so it won't take a tremendous amount of time but it is important that you come prepared.
- Think in terms of giving the attendees 2–3 key takeaways of value on PEARLS, i.e. if nothing else, you want them to know "x or y" from this event. Think about what you want your audience to takeaway from the presentation.
- Consider looking for ways to add new anecdotes, and new ideas to your presentation. Everyone loves a good story!
- We find that the best presentations are rehearsed, make sure to go over your presentation at least once before conference day.
- Aim to teach and entertain.
